### ORDER

Bhanu Prakash Tyagi communicated a letter of Representation along with the Copy of Order dt. 16.11.2013 passed by Hon'ble High Court of Allahabad in Writ-C No. 70966 of 2013 and 66347 of 2013.

Whereas, I have examined the order passed by the Hon'ble High Court and also assessed the representation. I am deeply hurt by the language of the representation and rather it would be appropriate to say that the language used is highly harsh with the threat of Contempt. However, being the well-wisher and teacher, I am not taking into account and always insisted for the better future of students. Therefore I decide the representations of the students on merit.


Whereas, I have seen the conduct of Vibgyour Institute. Vibgyour institute Muzaffar Nagar did not adhere to the guidelines of University. Now the examination of all the students of said institute will be conducted by the University at IASE (D) University Campus, Gandhi Vidhya Mandir Sardarsahr, Distt. Churu, Rajasthan. The institution is waiting for the response of all other students and thereafter the schedule of examination with all other formalities will be declared within due course. It is requested you to submit the tuition fee/fee of examination after the schedule is declared by the University.



Since the Vibgyour Institute Muzaffar Nagar is not cooperating with the IASE (D) University at all and even inspection cannot be conducted with IIMR institution. Keeping in view of the future of students, the results of all the students were declared by the Institute of Advanced Studies in Education (D) University and displayed on website as well as Notice board. The Copy of mark card will be sent to all those students who have not received the same within 30 days after filing the due details and completion of certain formalities prescribed by the University. You are therefore, requested to personally visit the office of Registrar with all documents on Second Saturday of any month to complete your formalities and the Copy of mark card will be sent within 30 days of completion of formalities.
